THE UNDERSIGNED subscriber to these Articles Of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I - NAME

THE NAME of the Corporation shall be THE C. K. SMITH FOUNDATION, INC., and shall have its principal place of business at 2703 17th Avenue West, Bradenton, Florida 34205.

ARTICLE II - DURATION

THE EXISTENCE of this Corporation shall be in perpetuity.
