# ARTICLES OF INCORPORATION FOR FLORIDA LADIES SPIRITUAL UPLIFT MINISTRIES INC.

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

#### ARTICLE I- NAME

The name of the corporation is FLORIDA LAIDES SPITITUAL UPLIFT MINISTRIES INC.

# ARTICLE II- PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 11281 S. W. 159 Street, Miami Florida 33157.

#### ARTICLE III - PURPOSE

The corporation is organized to promote a spiritual awareness and provide a ministry for women of all ages and from all walks of life. A forum that seeks to help and offer women an arena for encouragement, practical teaching, support, inspiration, hop, and to improve the quality of life for themselves and their families.

#### ARTICLE IV - THE MANNER OF ELECTION
