The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I- NAME**

The name of the corporation is  
**FLORIDA LAIDES SPITTUAL UPLIFT MINISTRIES INC.**

**ARTICLE II- PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 11281 S. W. 159 Street, Miami Florida 33157.

**ARTICLE III - PURPOSE**

The corporation is organized to promote a spiritual awareness and provide a ministry for women of all ages and from all walks of life. A forum that seeks to help and offer women an arena for encouragement, practical teaching, support, inspiration, hop, and to improve the quality of life for themselves and their families.

**ARTICLE IV – THE MANNER OF ELECTION**

The manner in which the directors are elected or appointed by a forum of twelve (12) committee members with each member casting one (1) vote upon the election of the officers. Vacancies in the Executive Committee shall be filled by a vote of the majority of the remaining members of the Committee. At no time shall the Executive Committee be less than twelve (12) Members. The Secretary shall be appointed by the Executive Committee and serve a term of no less than five (5) years. Each Committee member shall have one vote and proxy may not do such voting.
