ARTICLES OF INCORPORATION**

FUNDACIÓN PROPASTOR, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: **Fundación ProPastor, Inc.**

The principal place of business of this corporation shall be:
1725 Main Street, Suite 215, Weston, FL 33326.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law. The effective date of this corporation shall be May 7, 2002.

ARTICLE III

The purpose for which this corporation is organized is to contribute to the economic and social well being of persons around the world who are serving in the pastoral ministry of the evangelical church at large. Said corporation is organized exclusively for charitable and religious purposes, including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

The qualifications for directors and members, and the manner of their election and/or admission, are provided for in the bylaws of the corporation.

ARTICLE V

The number constituting the initial Board of Directors of the corporation is seven (7), and the names and addresses of the persons who are to serve initially are:

ARTICLE VI

This corporation is organized under a non-stock basis. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of

any prior or future law, or the Federal, State, or Local Government for exclusive public purpose.

ARTICLE VIII




