ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

CROOKED RIVER OAKS HOMEOWNER'S ASSOCIATION, INC

(Present name)

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida non profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted: (indicate article number(s) being amended, added or deleted) **Articles Added X and XI as follows:**

ARTICLE X - MANAGEMENT OF COMMON PROPERTY

The corporation shall have the power to own and convey property. The corporation shall also have the power to operate and maintain the common property, specifically the surface water management system facilities including all inlets, ditches, swales, culverts, water control structure, retention and detention areas, ponds, lake, flood plain compensation area, wetlands and any associated buffer areas, and wetland mitigation areas. The corporation shall also have the following specific powers :

- A. Establish rules and regulations concerning common property,
- B. Assess member of the Association and enforce said assessments,
- C. Sue and be sued
- D. Contract for services to provide for operation and maintenance if the Association contemplates employing a maintenance company,
- E. Require all the lot owners to be members of the Association
- F. Take any other action necessary for the purpose for which the Association is organized.

ARTICLE XI- DISSOLUTION OF CORPORATION

If the Association is dissolved, the property consisting of the surface water management system shall be conveyed to an appropriate agency of a local government, and if the same is not accepted, then the surface water management system shall be dedicated to a similar non-profit corporation
