## **ARTICLES OF INCORPORATION**

**In Compliance with Chapter 617 F.S., (Not for Profit)**

### **ARTICLE I NAME**

The name of the corporation shall be, "FLORIDA CONFERENCE ALLEN OUTREACH CENTER-  
AFRICAN METHODIST EPISCOPAL CHURCH; INC."

### **ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is exclusively charitable and educational to include but not limited to the following:

1. To raise the economic, educational and social levels of the citizens in Big Bend Area and adjacent counties with particular focus upon members of the minority community and others who reside in the specified regions, who are substantially unemployed, under-employed, or whose income is below federal poverty guidelines
2. To aid, support and assist by gifts, contributions, or other means of aid through association with other corporations, community chests, funds and foundations which are organized and operated exclusively for charitable and educational purposes. No part of the net earnings of which shall be used to benefit any private shareholder or individual, nor substantiate any part of activities, of which, promote propaganda, or otherwise attempt to influence legislation.
3. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or obtaining of the foregoing purpose, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, or governmental bureaus, departments or agencies.
4. All of the foregoing purpose shall be exercised exclusively for charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under 501(C) (3) of the Internal Revenue Code of 1986 or corresponding provisions of any future United States Internal Revenue law.

### **ARTICLE IV MANNER OF ELECTION**

Directors for the corporation are elected by the members at the annual meeting of the membership.


