## ARTICLES OF INCORPORATION OF INTERNATIONAL COLLEGE OF ENDOCRINOLOGY, INC.

2002 MAY 16 PH 2:07

The undersigned, being a natural person of the age of more than twenty-one years, does hereby act as FLORIDA incorporation in adopting the following Articles of Incorporation for the purpose of organizing a not for profit corporation pursuant to the provisions of the Florida Not for Profit Corporation Act.

**FIRST:** The name of the corporation ("Corporation") shall be the International College of Endocrinology, Inc.

The principal place of business of this corporation shall be 1000 Riverside Avenue, Suite 205, Jacksonville, County of Duval, Florida 32204.

**SECOND:** The duration of the corporation shall be perpetual.

**THIRD:** The purposes for which the Corporation is organized, which shall continue to be the purposes of the Corporation until and if the same be amended pursuant to the provisions of the Florida Not for Profit Corporation Act, and which shall include the authority of the Corporation to transact any lawful business for which a corporation may be incorporated under the Florida Not for Profit Corporation Act, are as follows:

The purposes for which the Corporation is organized and operated shall be to operate solely for charitable, scientific and educational purposes solely within the exemption provided for by 26 U.S.C.A., Internal Revenue Code, Section 501(c)(3), and any amendments thereto, namely:

- A. To promote the study of endocrinology and to seek to advance the specialty worldwide.
- B. To conduct cultural, educational, and social activities that will best carry out its purpose.
- C. To serve as a medium of communication between the members of the organization.
- D. To elevate the standards of training and education in endocrinology.
- E. To have all of the powers conferred upon corporations organized under the Florida Not For Profit Corporation Act.

Notwithstanding the foregoing or any other provision of these Articles of Incorporation, the Corporation shall not at any time engage in a regular business of a kind ordinarily carried on for profit, nor shall any part of the net earnings of the Corporation inure to the benefit of any member, officer, trustee or individual, nor shall it engage in any transaction which would cause it to be denied the status of an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code of the United States, as the same may be hereafter amended.

**FOURTH:** In the event of the dissolution of the Corporation, the Board of Trustees shall, after paying or making provisions for the payment of all the liabilities of the Corporation, distribute all of the assets remaining to such charitable, educational, or scientific organizations as shall from time to time qualify as exempt organizations pursuant to Sections 501(c)(3) of the Internal Revenue Code, as the same may be hereafter amended.

**FIFTH:** The address of the initial registered office of the Corporation in the State of Florida is 1000 Riverside Avenue, Suite 115, Jacksonville, County of Duval, Florida 32204; and the name of the initial registered agent of the Corporation at such address is Christopher L. Nuland.

SIXTH: The standards for eligibility of members shall be contained in the Bylaws of the Corporation.

**SEVENTH:** The manner in which the Trustees of the Corporation shall be elected shall be contained in the Bylaws of the Corporation.
