## ARTICLES OF INCORPORATION

The undersigned acting as incorporation pursuant to chapter 617, Florida Statutes, Adopt(s) the following articles of incorporation:

### ARTICLES 1

The name of the corporation shall be:

### ARTICLES 3

#### Purposes(s)

The specific purpose(s) for which this corporation is organized is exclusively for one of the purposes as specified in Section 501 (c) (3) of the Internal Revenue Code including for charitable, educational, religious, and scientific purposes. The making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Service or corresponding section of any future Federal tax code.

The Better Living Standards Project was established to provide affordable housing for the very low to moderate income families and individuals. We will target the elderly, single men and women, migrant workers, disabled, and families. Our future and immediate goal will also be to assist these families and individuals with community services that will help them achieve a better standard of living through working with other non-profit organizations that will assist them with their needs. We will offer food programs, work with immigration services, and any other program that that will help them to lead a successful life. Also for those who are in need of educational services we will also provide assistance with these services.

### ARTICLES 4

#### Manner Of Election Of Directors

The manner in which the directors are elected or appointed is as follows: the election of all directors shall be by written ballot. All qualified persons must be an active member of the organization. Must obey the rules and regulations. Must share in the visions of the organization and the interest of all members. He/she must exhibit good public relation skills, and must be voted in unanimously by all other existing board members.

### ARTICLES 5

The corporate powers of this corporation are provided in section 617.0302, Florida Statutes, unless limited as follows.

## ARTICLES 8 Additional/Provisions

Upon the dissolution of this corporation, its assests remaining after payment, or provisions for payment, of all debts, and liabilities of this corporation shall be distributed for one or more exemption purposes within the remaining of section 501 (c) (3) of the Internal Revenue Code or shall be distributed to the federal government, for a public purpose(s).

No substantial part of the activities of this corporation shall consist of carrying on proper gander, or other wise attempting to influence legislation (except as otherwise provided by section 501 (H) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), or any political campaign on behalf of, or in opposition of any candidate for public office).

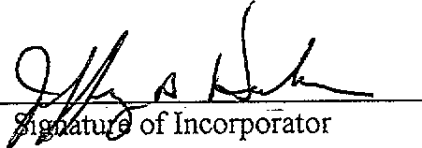
No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to it's members, directors, officers, or other private person, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles , this corporation shall not carry any other activities not permitted to be (1) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or (2) by a corporation contributions to which are deductible under section 170 C 2 of the Internal Code.

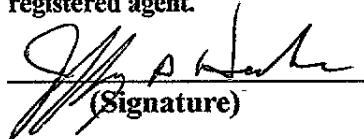
