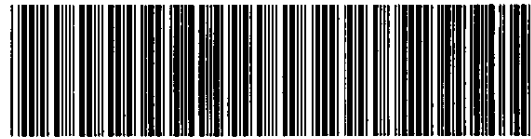



Pursuant to Section 617.1401, Florida Statutes, we, the undersigned, hereby execute, acknowledge and file the following Articles of Dissolution for the purpose of recording the dissolution of Human Rights and National Reconciliation Cuban Commission, Inc., a Florida corporation not for profit organized under the laws of the State of Florida, to wit:

ARTICLE I - Name

The name of the corporation is Human Rights and National Reconciliation Cuban Commission, Inc. (the "Corporation").

ARTICLE II - Incorporation

The Articles of Incorporation were filed with the Florida Department of State on May 17, 2002 and assigned document number N02000003814.

ARTICLE III - Affairs of the Corporation

The corporation has not commenced to conduct its affairs.

ARTICLE IV - Debts

No debts of the corporation remain unpaid.


ARTICLE V - Resolutions of the Voting Members and Board of Directors

The Board of Directors and Voting Members of the Corporation by a unanimous written consent dated September 30, 2010 decided to authorize the dissolution of the Corporation.
