In the name of Jesus, our Lord we the undersigned, do associate together to form and establish a non profit corporation under the law of the State of Florida

We thereby, adopt and agree to the following articles:

I

The name of said corporation, organization or church (to be use interchangeable throughout these articles) shall be called The Church of The Living God In Christ of Gainesville incorporation rated.

This corporation is a non-profit organization, Non denominational Ministry that is anointed by God.

This organization's object is that

VII

The general offices of this organization shall be the Pastor, Assistant Pastor, Trustees, Deacons, Deaconess, Ministers, and board Members.

- A) Pastor is the spiritual leader of the flock, whose job is to be a good, strong, faithful leader, to lead and guide the flock in the ways of the Lord, with oversight and insight in spirit and in truth. The Pastor shall be selected by the Church and remain Pastor until his resignation or death
- B) Assistant Pastor shall carry out the duties of the Pastor in his stead, when the Pastor is unable to serve. The assistant Pastor is

- elected through nomination of the Pastor and selected by the Church, and likewise removed.
- C) Trustees shall be responsible for the upkeep of the Church, its financial needs i,e. The purchase and maintenance of such items as musical instruments, chairs, air conditioner, and a place of worship. Trustees are nominated by the pastor, approved by membership to serve until they resign. Or for a good cause removed by the pastor and the board in the same capacity as Directors of the Corporation. They shall meet with the pastor twice a month. A place designated by the by-laws of the church. If someone is moved, the Trustee board has the authority to fill that vacancy.
