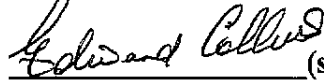

ONE: The name and address of this Corporation is End Time Pentecostal Deliverance International Ministries Inc., 529 Brighton Court, Kissimmee Florida 34758. This Corporation is organized pursuant to the Florida Nonprofit Corporation Code.

TWO: This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of JESUS CHRIST. The corporation is organized under the Non-profit Public Benefit Corporation Law, for Religious purposes to establish structured support service for Evangelistic, Economic Development and other Ministries to support the outreach ministries for the body of JESUS CHRIST (The Church). THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

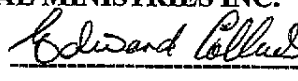
