The undersigned, desiring to organize a Corporation under Chapter 617, Florida Statutes, set forth the following:

ARTICLE I

The name of this Corporation shall be **TAKE THIS MOUNTAIN MINISTRIES, INC., A FLORIDA CORPORATION NOT FOR PROFIT.**

ARTICLE II

The address of the Principal Office of the Corporation and the mailing address of the Corporation is:
