ARTICLES OF INCORPORATION (In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I - NAME

The name of the corporation shall be, Christian Life Center Ministries, Inc. It shall be incorporated as a non-profit-making religious organization under the laws of the State of Florida.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

Christian Life Center Ministries, Inc. is a cooperative fellowship, based upon mutual agreements, voluntarily entered into by its membership to attain the following goals:

- 1. To accomplish our Three-Fold Reason-for-Being which are:
 - a. To encourage and promote the edification of believers.
 - b. To encourage and promote the worship of God.
 - c. To encourage and promote the evangelization of the world.
- 2. To approve all scriptural teaching, methods, and conduct, and disapprove all unscriptural teaching, methods, and conduct.
- 3. To provide a basis of fellowship among Christians of like precious faith.

 - c. Testimony of having experienced the new birth.
 - d. Testimony of having received or ardently seeking for the baptism of the Holy Spirit.
 - e. Maintaining Christian character as per Titus 1:7; I Timothy 3:7.
 - f. An active loyalty to our constitutional agreements and a cooperative spirit.
