# ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

### ARTICLE I

The name of the corporation shall be:

BOAT JACKSONVILLE, INC.

# ARTICLE III

The purpose for which the corporation is organized is:

Boat Jacksonville, Inc. is an association created to assist in the expansion of the boating community in Northeast Florida through enhancement of the public's knowledge in navigation, water access, safety and other boating related issues facilitated by its membership consisting of committed marine industry professionals.

# ARTICLE IV

Membership is as follows:

Any individual with an interest in the purposes of the corporation shall be eligible for membership in accordance with the by-laws and rules and regulations in effect from time to time. There shall be no limit on the number of members. # ARTICLE X

### Indemnification:

Private property of the incorporators, directors, or officers, of the corporation shall not be subject to the payment of any corporate debts, liabilities or obligations. To the fullest extent permitted by the law of the State of Florida, the corporation shall indemnify any director or officer or the corporation for any liability arising by virtue of such directors or officers position or former position with the corporation.
