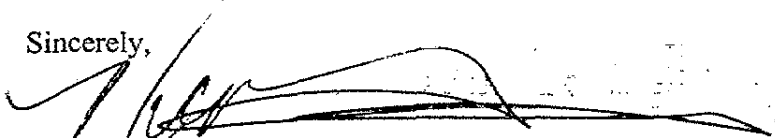

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
STARR VISION INCORPORATED
(A NON-PROFIT, NON-MEMBERSHIP ORGANIZATION)**

Pursuant to the provisions of Chapter 617.1006 et seq. of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:
