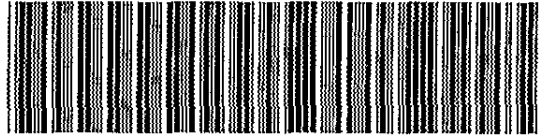



**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
STARR VISION INCORPORATED
(A NON-PROFIT, NON-MEMBERSHIP ORGANIZATION)**

Pursuant to the provisions of Chapter 617.1006 et seq. of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **STARR VISION INCORPORATED**.
2. The following amendments to the Articles of Incorporation were adopted by the Board of Directors of the corporation on November 15, 2002, in the manner prescribed by the Florida business Corporation Act:
