ARTICLES OF INCORPORATION

The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation not for profit under the Laws of the State of Florida, and hereby adopts the following Articles of Incorporation.

Article I – Name

The name of this corporation shall be:

UNIDOS POR LA VIDA, INC.

Article II – Principal office

The principal place of business of this corporation shall be:

1320 SW 1 Terri, Pompano Beach, Florida 33060-8720

Article III – Purpose

The general nature, object, and purpose of this corporation is as follows:

To improve the living conditions of residents of economically depressed areas through a variety of activities, which include social, educational, productive, and cultural activities. The aforementioned activities will take places in United State territory. However, we will attempt to extend our activities abroad, including Latin-America, and others. Moreover, our main objectives are to improve the

mother/children relationship, and to render counseling concerning domestic abuse.

The corporation shall have the power to buy, acquire, and hold titles of fees, in trust, or otherwise, to both business and personal property, and improve, encumber, sell, convey and dispose of all such property, to borrow money, execute notes, bonds, and other evidences of indebtedness and to secure the same by mortgages and deeds of trust, annuity bond, and other instruments of indebtedness and to pay interest thereon, to improve, adapt, and use property held by it or the income therefrom in the educational, benevolent, or social activities of the corporation or its successor without financial profit to its members except as may be necessary in the payments of salaries, or other compensation for services rendered, and the corporation shall have the power to erect and maintain in article II, of the officers of UNIDOS POR LA VIDA, INC., in conformity with the by-laws of said corporation and all the power and rights granted to Not-for-Profit Corporations, under the Laws of the State of Florida.

Article IV- Membership

Members of the corporation shall be appointed to specified positions, Term length of appointed positions are effective for the length of two years, with the option of running for a second term. The maximum allowable number of terms is two terms (4 years) per member, per position.

Article V- Term

The titles of the positions within the corporation include: president, vice president, secretary, treasurer, and counselor and these Articles are as follow:
