**Article of Incorporation
Of
Full Faith, Inc.**

The undersigned acting as incorporator of a Corporation under the Fla. Statutes, adopts the following Articles of Incorporation.

Article I

The name and address of this Principal Corporation is Full Faith, Inc. 4741 Pilgrim Way, Orlando, Fla. 32808.

Article II -(Purpose)(s)

The purpose for which the corporation is organized: is to enlighten the community and to bring to their awareness that we are in the business of reconciling man back to God. We will assist the community by aiding those that are in need of support through a variety of services. Our purpose is to enhance them with the appropriate information that would sustain and help them live a better and a productive life. Whether it is through the provision of food, clothing, referred counseling, substance prevention, referred employment, health deficiencies, or due to the death of a love one, we are interest in the total aspect of the humanity.

Article III

The duration of this Corporation shall be perpetual, no stock and no members.

Article IV

The address of the registered office is 4741 Pilgrim Way, Orlando, Fla. 32808. The name of the registered agent of the Corporation shall be Kimberly Wright.

Article V

(a) This Corporation is organized and operated exclusively for Religious, Charitable and Education purpose with, the meaning of section 501(c)(3) of the Internal Revenue Service Code.

(b) Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to carry on.

(1) By a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (2) by a Corporation contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code

Article VI

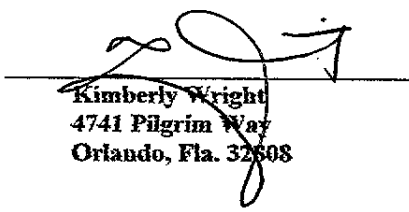
Article VIII

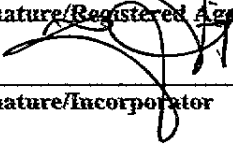

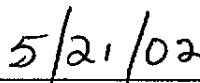

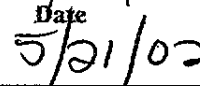
