

ARTICLES OF INCORPORATION
OF
FAMILIES AGAINST DRUGS OF GAINESVILLE, INC.

A FLORIDA NONPROFIT CORPORATION

ARTICLE ONE - NAME AND ADDRESS

The name of the Corporation is FAMILIES AGAINST DRUGS OF GAINESVILLE, Inc. and the address of the principal office of the corporation is 2114 N.W. 40th Terrace, Suite A-1, Gainesville, FL 32605, and the mailing address of the corporation is 2114 N.W. 40th Terrace, Suite A-1, Gainesville, FL 32605.

ARTICLE TWO - DURATION

The term of existence of the Corporation is perpetual; and the corporate existence will commence business on the day of the filing of these Articles of Incorporation.

ARTICLE THREE - PURPOSE

Said corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future federal tax code).

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) concerning any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Service Code of 1986 (or corresponding section of any future federal tax code).

ARTICLE FOUR - DIRECTORS




