Articles of Incorporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be **Palm Beach Mountain Bike Association Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III PURPOSE

The specific purpose for which the corporation is organized is to provide volunteers to assist the Palm Beach County Parks and Recreation Dept and the Solid Waste Authority and any other agency requesting services to design, build, and maintain mountain bike trails. Also, to provide educational services by improving intermediate rider skills and bring new riders, both young and old, into the sport of mountain biking.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall consist of seven (7) members and shall be elected as follows:

Chief Executive Officer: is a permanent position of the incorporator until such time as said person resigns, then the position shall be appointed by the board.

President: shall be an elected position to serve a term of two (2) years, elected on odd years.

Vice-President: shall be an elected position to serve a term of two (2) years, elected on even years.

Secretary: shall be an elected position to serve a term of two (2) years, elected on odd years.

Treasurer: shall be an elected position to serve a term of two (2) years, elected on even years.

Trail Coordinator: This number shall vary dependant on the number of trails we maintain and shall be appointed by the Board of Directors to serve until such time as the person resigns or is removed by a majority vote of the Board of Directors.

Additional election procedures and duties shall be covered as stated in the bylaws.
