ARTICLES OF INCORPORATION

COMMUNITY SOCIAL SERVICES OF TARPON SPRINGS, INC.

The undersigned, acting as incorporator(s) of a non-profit corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following **ARTICLES OF INCORPORATION**:

Article I, Name: The name of this corporation shall be;

Community Social Services of Tarpon Springs, Inc.

Article II, Principle Place of Business & Mailing Address;

Article III, Purpose(s); The specific purpose(s) for which this corporation is organized (are):

The purpose(s) for which **Community Social Services of Tarpon Springs, Inc.** is organized are exclusively religious, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any provision of these articles, this organization shall not carry on any activities not permitted to be carried on by any organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

This corporation shall also establish social ministries wherever deemed necessary for the purpose of providing: Pastoral Counseling; food pantries to assist the needy; soup kitchens to feed the poor and homeless; mentoring; to serve as a referral base for those in need of city, county, state and federal programs that enhance the quality of life; and other ministries that may be deemed necessary.

Article IV, Manner of Election of Directors; The manner in which Directors are elected shall be as follows:

The by-laws shall state the manner in which Directors of this corporation shall be elected.

Article V, Limitations of Corporate Power;

The corporate powers of this corporation are as provided in Section 617.03, Florida Statutes, unless limited, are as follows:

Subject to the limitations contained in the by-laws, and any limitations set forth in the corporate not for profit laws of the State of Florida, by-laws may be made, altered, rescinded, added to, or new by-laws may be adopted, either by resolution, or by following the procedure(s) set forth in the by-laws.

Article VI, Dissolution

In the event of dissolution of this corporation by majority action of the Board of Directors, any monies remaining shall be given to that ministry and/or ministries as may be required by law.
