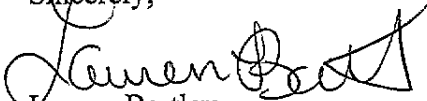

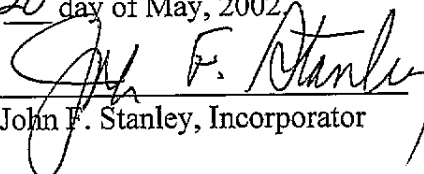
ARTICLE VI DURATION

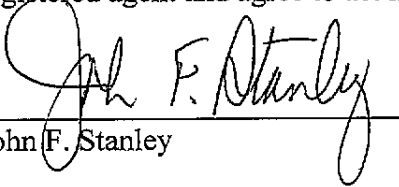
