**ARTICLES OF INCORPORATION**  
**SHILOH MISSIONARY BAPTIST CHURCH OF TAVARES, INC.**  
**A CORPORATION NOT FOR PROFIT**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be SHILOH MISSIONARY BAPTIST CHURCH OF TAVARES, INC.

**ARTICLE II**

The principle place of business is 223 Ingraham Avenue, Tavares, Florida 32778 and the mailing address of this corporation shall be P.O. Box 464, Tavares, Florida 32778.

**ARTICLE III**
