#### ARTICLES OF INCORPORATION

## ARTICLE I NAME

SECKETARY OF STATE TALLAHASSEE FLORIDA

The name of the corporation shall be Access Hernando, Inc., a voluntary, non-profit corporation of Florida.

## ARTICLE II PRINCIPAL OFFICE

The corporation headquarters shall be located at: 14540 Cortez Boulevard, Suite 204, Brooksville, Florida 34601, or such other place as may be designated from time to time by the Board of Directors.

## ARTICLE III PURPOSE

The term of existence of this Corporation shall be perpetual and its purpose shall be the following:

- A. To gather together healthcare physicians and providers to overcome barriers to healthcare provider volunteerism.
- B. To establish a core of physicians, nurse practitioners, physicians assistants, and other healthcare professionals committed to participating in a network to ensure that eligible Hernando County residents have access to healthcare services.
- C. To improve access to medical care to eligible Hernando County residents in need of primary, specialty, and ancillary care services.
- D. To improve the quality of life of uninsured eligible residents in Hernando County.

# ARTICLE IV MANNER OF ELECTION

- A. Membership in the Corporation shall consist solely of the Board of Directors as specified below and three non-voting consultant members: one attorney, one auditor, and the Director Hernando County Social Services.
- B. The Bylaws of the Corporation may provide for classifications of membership and conditions of membership and rights and duties thereof.

- C. The membership of the Board of Directors of the Corporation shall meet all of the provisions of incorporation as specified by State law.
- D. The membership of the Board of Directors shall be appointed as follows:

Members of the Board of Directors of the Corporation shall represent two (2) physicians of the Hernando County Medical Society: the President and his/her designee; the chief executive officer (CEO) at Oak Hill Hospital; the CEO of the Brooksville/Spring Hill Regional Hospital system; the medical chief of staff at Oak Hill Hospital; the medical chief of staff of the Brooksville/Spring Hill Regional Hospital system; the Medical Director of the Hernando County Health Department; the Administrator/Director of the Hernando County Health Department; a commissioner from the Hernando County Board of County Commissioners; and a physician representative (MD/DO) from the Hernando County Health Care Advisory Board. These aforementioned members of the corporation will hereinafter be referred to as the Board of Directors.

- B. Upon proper notice, the Articles of Incorporation may be amended, altered, or rescinded by a majority vote of those voting members of the Board of Directors of the Corporation present at the regular meeting or special meeting called for that purpose, providing that the notification of the meeting also includes the notice of the proposed amendment to the Articles.
