### AMENDMENT TO THE ARTICLES OF INCORPORATION OF PALMETTO PLACE AT MIZNER PARK CONDOMINIUM ASSOCIATION, INC.

The original Declaration of Palmetto Place, The Condominium is recorded in Official Records Book 14696, at Page 924, in the Public Records of Palm Beach County, Florida. The Articles of Incorporation for Palmetto Place at Mizner Park Condominium Association, Inc. is recorded in Official Records Book 14696 at Page 1070, in the Public Records of Palm Beach County, Florida.

As indicated herein, words <u>underlined</u> are added and words <del>struck through</del> are deleted.

Item 1: Article 10, Section 10.1 of the Articles of Incorporation for Palmetto Place at Mizner Park Condominium Association, Inc. ("Articles") shall be amended by as follows:

10.1. Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall consist of not less than three (3) directors. Directors need not must be members of the Association.
