### **PROJECTS**

Counseling will be of a spiritual nature to individuals, couples and small groups at first. Our goal will be to expand the size of groups and have guest speakers come for seminars/workshops.

Establish groups to assist the elderly and single parents to reduce their level of stress and pressure that exists in keeping, transporting and scheduling appointments. We believe this service will also decrease the responsibility and load of family members and increase the family structure. A network of volunteers will be available for child care services for short durations so single parents can run errands, keep appointments and make day to day life easier.

The elderly who have handicaps and need assistance have reached out to our ministry to help support them on a day-to-day basic so that they can remain independent and self-sufficient. This group needs minor renovations to their homes. Until more funding is acquired we are networking with the county and other programs to assist them with their need.
