THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE  
TO ITS MEMBERS, TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS,  
EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED
