Name and Offices

Article II

Corporate Offices

The principle office shall be located at Route 3 Box 405 Lake Butler, Fl. 32054. The Corporation may also have offices at such other places as determined by the Board of Directors. These offices may be within or without of the State of Florida.

Article III

Purposes

This Corporation shall be organized and operated for religious purposes to:

1. Minister the Word of God;
2. Conduct religious services through various forms of ministry;
3. Promote and encourage, through various ministries of the organization, cooperation with other organizations ministering within the community;
4. Spread the Word of God through seminars, conventions, radio, and other forms of mass media for the purpose of educating in the Word of God;
5. To conduct a local church by direction of the Lord, Jesus Christ and under the leadership of the Holy Spirit in accordance with all the provisions as set forth in the Bible. To recongnize the office of the Pastor as the visionary of the total ministry of the local church and to serve as an assistant in fulfilling the vision God gives under his leadership;

6. To conduct a Christian School as well as a school of Ministry to train ministers;
7. To license and ordain those called to the office of ministry and to assist , when possible, in the establishing of fellow churches as the Chairman/President and/or Board of Directors deem possible.

Article IV

Elections and Appointments

The Board of Directors of International Lighthouse Ministries, Incorporated shall be by appointment of the Founder and Chairman/President of the Board. The Board shall consist of Founder and Chairman/President, Pastor Wilbur Regar, Vice President, Dorothy Regar, Secretary-Treasurer And two fellow ministers chosen by Chairman/President of Corporation. Secretary-Treasurer, and Ministers serving as Board Members are for a one year term and may serve as many terms as Chairman/President deems appropriate.

Be it further known that the office of Chairman/President and Vice President shall be held by Pastor Wilbur Regar as Chairman/President and Dorothy Regar as Vice President indefinitely. It shall be understood that Pastor Wilbur Regar shall be Pastor of International Lighthouse Ministries, Incorporated indefinitely.
