WE, THE UNDERSIGNED, hereby associate ourselves for the purpose of forming Florida corporation not- for-profit pursuant to Chapter 617 of Florida Statutes as amended and certify as follows:

**ARTICLE 1**

**NAME AND PRINCIPAL OFFICE**

The Name of this corporation shall is **Suncoast Animal Rescue League Inc.** a Florida not-for-profit corporation. The principal office of the corporation is 2822,42<sup>nd</sup> Avenue North, St.Petersburg, Florida 33714

**ARTICLE 11**

**PURPOSES AND POWERS**

- a. The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of Internal Revenue Code 501© 3 or the corresponding provision of any future United State Internal Revenue law.
- b. Not withstanding any other provisions of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under IRC 501© 3 or the corresponding provision of any future United States Internal Revenue law.
- c. This corporation is organized to establish and maintain a rescue program for abandoned, mistreated or unwanted dogs and cats regardless of weather such animals are purebred or registered with any Kennel Club.
- d. This corporation may exercise all powers granted to a not-for-profit corporation under the State of Florida.

## **ARTICLE 111**

### **MEMBERSHIP**

The qualification for membership and manner of admission is provided in the bylaws.

## **ARTICLE 1V**

### **DURATION**

The corporation shall have perpetual existence. Corporate existence shall commence upon filing with the Secretary of State.

## **ARTICLE V**

### **MANAGEMENT**

- a. The affairs of the corporation shall be managed by a Board of Directors, which shall be elected at the annual meeting of the corporation. The Board of Directors shall consist of not fewer than (4) persons but be any number in excess thereof. Directors shall be elected or removed in accordance with the procedure provided in the bylaws.
- b. The officers of the corporation shall be a President, a Vice President, a Secretary, and a Treasurer. The officers shall be elected and shall hold office in the manner provided in the bylaws.
