ARTICLE VIII: PERSONAL LIABILITY

No officer or director of The Corporation shall be personally liable for the debts or obligations of The Capital City Garden Club, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of the corporation.

In the event of dissolution, the residual assets of the corporation, after financial obligations have been met, any and all funds, including the land and building will be turned over to Florida Agricultural and Mechanical University 4-H Youth Program or to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any prior or future federal tax code or law, or to the Federal, State or Local government, for public purpose.
