ARTICLES OF INCORPORATION '

Articles of Incorporation of LAW ENFORCEMENT TECHNOLOGY CENTRE, INC.

The undersigned, a citizen of the United States, acting as incorporator of a corporation under the Not-for-Profit Corporation Laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Law Enforcement Technology Centre, Inc.

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The place of business and the mailing address of this corporation shall be:

ARTICLE III PURPOSE

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under Section 501(c)3 of the Internal Revenue Code, or corresponding sections of any future federal tax code.

No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall no participate in, or intervene in)including the publishing or distribution of statements any political campaign on behalf of or in opposition to any candidate for public office. Notwithständing any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)3 of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets of Common Please of the country in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
