NLP HOME OWNERSHIP FUND, INC., a not-for-profit corporation duly organized and existing under the Florida Not-For-Profit Corporation Act, *as amended*, Florida Statutes, Chapter 617, hereby certifies as follows:

Pursuant to the written consent of the sole member of the Corporation, in lieu of a special meeting, which vote was sufficient for approval, the following resolutions were adopted on September 11th, 2002, amending the Articles of Incorporation as follows:

**RESOLVED**, that Article I of the Articles of Incorporation filed with the Secretary of State of Florida be amended as hereinafter set forth:

"The name of this Corporation is: **NEIGHBORHOOD LENDING PARTNERS HOMEOWNERSHIP FUND, INC.**"

**FURTHER RESOLVED**, that Article XV of the Articles of Incorporation filed with the Secretary of State of Florida be amended as set hereinafter set forth:

"The street address of the registered office of this Corporation is:

Tampa, Florida 33602.

The name of the registered agent of this Corporation at such address is: **Andrew Service Corporation of Florida, Inc.** #624257

The registered office and registered agent of the Corporation may be changed from time to time in the manner provided by law."

**FURTHER RESOLVED**, that the officers of the Corporation be, and hereby are, authorized to take such action as may be necessary to effect the foregoing resolutions including, but not limited to, executing and filing with the Florida Secretary of State the Articles of Amendment to the Articles of Incorporation and a Statement of Change of Registered Agent.


