Articles of Incorporation

Articles of Incorporation of the undersigned, who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I - Name: The name of the Corporation shall be "Legal Gospel News, INC".

Article II - Principle Office: The place in this state where the principal office of the Corporation is to be located is the City of St. Petersburg, Pinellas County. Cynthia Allen

Article III - Purpose: To publish news and meet a range of informational needs of faith-based communities in the Tampa Bay area. This paper is intended to increase the flow of news, announcements, activities, ministries, goods and services of churches, neighborhood association and faith-based initiatives and religious owned business throughout the targeted area. To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

Article IV - Election: The Board, pursuant to the recommendation of the President, will elect the officers of the Corporation annually. Each such officer shall hold his or her office until he or she resigns, is removed, is otherwise disqualified to serve, or his or her successor is elected.

Article V: - Directors / Officers: The names and addresses of the persons who are the initial officers of the corporation are as follows:





Article VII: The undersigned incorporator certify that she execute these articles for the purpose herein stated.


