**ARTICLES OF INCORPORATION**

**OF**

**Keep It Real Ministries of Orlando, INC.**

**A NON-PROFIT CORPORATION**

The undersigned incorporator(s), in order to form a non-profit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

**ARTICLE ONE**

The name of this corporation is **Keep It Real Ministries of Orlando, INC.** The street address of the initial principle office of the corporation is **514 S. Parramore Ave., Orlando, Florida 32805.** (Hereinafter the "Corporation")

**ARTICLE TWO**

The name and address of the registered agent of this corporation is:

**Duane M. Burke**

**514 S. Parramore Ave.**

**Orlando, Florida 32805**

**ARTICLE THREE**

The specific purposes for which this corporation is organized are:

- (a) To assist in and contribute to the academic, physical, spiritual and social development of the youth of Orlando and the Central Florida areas, through classroom teaching, youth rallies seminars, workshops, and parent/teen awareness clinics.
- (b) To provide financial assistance to the Keep It Real <sup>At Risk Youth</sup> ~~Youthful Offenders~~ Program designed to help troubled young men between the ages of 13 and 19 years of age rehabilitate themselves, reach goals and learn skills that will make them productive citizens.
- (c) To provide financial and management assistance for the <sup>Lighthouse</sup> ~~Cindy's Girls~~ Home and Boarding School, an outreach ministry of the Keep It Real Ministries of Orlando, INC.

- (d) To solicit gifts and bequest and to administer funds received in connection with the purpose of the Corporation.**

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This Corporation shall not take any of the following actions:

- (a) Engage in any act of self dealing;**
- (b) Retain any excess business holdings;**
- (c) Make any investments that will subject the Corporation to taxation;**
- (d) Make any taxable expenditures as defined under the Internal revenue Code;**

#### **ARTICLE FOUR**

The number of initial directors of this corporation is three (3). The method of electing said directors and executive committee shall be as provided in the Bylaws. The Executive Committee shall have the authority to adopt, alter, amend and repeal Bylaws of the Corporation. Directors will not be personally liable for decision made on behalf of the foundation in accordance with the Articles and the Bylaws of the Foundation. Their names and address are as follows:

#### **ARTICLE FIVE**

## **ARTICLE SIX**

The period of duration of this corporation is perpetual, unless sooner dissolved by law.

## **ARTICLE SEVEN**

The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows:

This corporation shall have voting members made up of the board of directors. In addition the corporation shall have non-voting members made up of those individuals and organizations making contributions to the corporation. Non-voting members shall be members for (1) one year following the date of the contribution to the Corporation. Non-voting members shall receive no benefits from the Corporation, nor shall not exercise any control over the assets, business or affairs of the Corporation, and shall not have any right of claim to any monies or property of the Corporation. Additional provisions specifying the rights and obligations of members shall be contained in the Bylaws of this corporation pursuant to, and in accordance with, the laws of this state.

## **ARTICLE EIGHT**

Any additional provisions for the operation of the corporation are as follows:

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

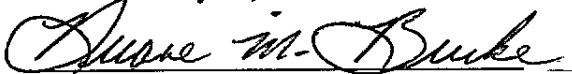
No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a

corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

The undersigned incorporators hereby declare under penalty of perjury that the statements made in the foregoing Articles of Incorporation are true.
