The undersigned have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

#### ARTICLE 1

The name of the corporation is <u>Section One</u>, The Beach House South TownhomesOwners <u>Association</u>, Inc., hereinafter called the "Association".

#### ARTICLE II

The principal office of the Association is located at 1409 Atlantic St., Melbourne Beach, FL 3295)

#### ARTICLE III

#### PURPOSE AND POWER OF THE ASSOCIATION

This association does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which the Association is formed is to provide for maintenance, preservation and architectural control of the residence lots and Common Area within that certain tract of land described as:

Lots 1, 2, 3, 4, 5 and 6, BLOCK 25, WILCOX PLAT OF MELBOURNE BEACH, according to the Plat thereof as recorded in Plat Book 1 at Page 58 of the Public Records of Brevard County, Florida

And to promote the health, safety and welfare of the residents within the above described property and any additions thereto as may hereinafter be brought within the jurisdiction of this Association for this purpose to:

- A. exercise all the powers and privileges and to perform all of the duties and obligations of the Association as set for in that certain Declaration of Covenants, Conditions and Restrictions, hereinafter called the "Declaration", applicable to the property and recorded or to be recorded in the public records of Brevard County, Florida and as the same may be amended from time to time as therein provided said Declaration being incorporated herein as if set forth at length.
- B. Fix, levy, collect and enforce payment by any lawful means all charges and assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of business of the Association, including all

licenses, taxes or governmental charges levied or imposed against the property of the association;

- C. Acquire (by gift, purchase or otherwise) own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association;
- D. Borrow money, and with the assent of two-thirds (2.3) of each class of members, mortgage, pledge, deed in trust or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- E. Dedicate, sell or transfer all or any part of the Common Area to any public agency, authority, or utility for such purposes and subject to such conditions as may be agreed to by the members. No such dedication or transfer shall be effective unless an instrument has bee signed by two-thirds (2.3) or each class of members agreeing to such dedication, sale or transfer;
- F. Participate in mergers and consolidations with other nonprofit corporations organized for the same purposes or annex additional residential property and Common Area, provided that any such merger, consolidation or annexation shall have the assent of two-thirds (2/3) of each class of members;
- G. Have and to exercise any and all powers, rights and privileges which a corporation organized under the non-profit Corporation Law of the State of Florida by law may now or hereafter have or exercise.

#### ARTICLE 1V

# Manner of Election

Every person or entity who is a record owner of a fee or undivided fee interest in any lot which is subject by covenants of record to assessment by the Association, including contract sellers, shall be a member of the Association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. A membership shall be appurtenant to and may not be separated form ownership of any lot which is subject to assessment by the Association.
