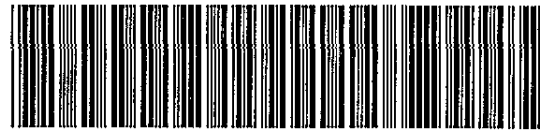

*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST: Amendments adopted:**

Amend ARTICLE III PURPOSE

The organization is organized exclusively for charitable, educational, scientific, and literary purposes under section 501(c)(3) of the Internal Revenue Code to scientifically research and develop working organic farms with effective soil, water, and wildlife conservation; to publish findings for the scientific and general community; and to provide cooperative education experiences empowering individuals and organizations as responsible stewards of their well-being and the environment.

Add ARTICLE IV EXEMPTION REQUIREMENTS

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Amend ARTICLE IV MANNER OF ELECTION to ARTICLE V

Amend ARTICLE V INITIAL DIRECTORS/OFFICERS to ARTICLE VI

Add ARTICLE VII DISSOLUTION

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
