Articles of Incorporation for Faith Missions Inc.

Article I Name

The name of the corporation shall be Faith Missions Inc.

Article II Principal Office

The principal place of business and mailing address of this corporation shall be

Article III Purpose

The purpose for which this corporation is organized is exclusively for religious purposes to promote, by every possible means, missions programs which are in accordance with evangelical Christian beliefs, both foreign and domestic; and in connection with the promotion of such programs to engage in evangelistic work through publications and speaking engagements and to work with young people and all other reasonably related activities in support of the main purpose including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV Board of Directors Election

The Board of Directors shall vote on any future members to be added to the Board of Directors as needed as in the case of resignation of a current Board member. A majority vote is needed for any person to be elected to the Board of Directors and the Board of Directors shall maintain a minimum of three directors at all times.

Article VIII Distribution of Net Earnings

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IX In Event of Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service or process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
