ARTICLES OF INCORPORATION

OF

WINTER PARK YACHT CLUB, INC.

The undersigned, acting as the incorporator of Winter Park Yacht Club, Inc., a Florida not-for-profit corporation (the "Corporation") under the Florida Not For Profit Corporation Act (the "Act"), submits the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is Winter Park Yacht Club, Inc..

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the initial principal place of business of the corporation is 2111 Via Tuscany, Winter Park, Florida 32789. The initial mailing address of the corporation is P.O. Box 2830, Winter Park, Florida 32790.

ARTICLE III - PURPOSE

The general object and purpose for which the corporation is organized is to encourage the sport of sailing, Kayaking, canoeing and other boating and to promote the science of seamanship and anchorage for the recreation of its members on a nonprofit basis and make available for the youth of the Club the opportunity to learn and practice seamanship. This Corporation is organized and shall be operated as a nonprofit organization under the Act exclusively for the purpose of promoting a common business interest as described in Section 501(c)(7) of the Internal Revenue Code of 1986, as amended, or any corresponding provision of any future United States Internal Revenue law (the "Code"), and conducting any and all lawful affairs for which a Florida nonprofit corporation may be incorporated under the Act; provided, however, that the Corporation may not engage in any activities not permitted to be carried on by a corporation described in Section 501(c)(7) of the Code.

ARTICLE IV - MANNER OF ELECTION

The Directors of Winter Park Yacht Club, Inc. have been duly appointed.
