## ARTICLES OF INCORPORATION INSTITUTE FOR SURVIVORS OF INCEST AND SEXUAL VIOLENCE INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617. Florida Statutes adopts the following Articles of Incorporation:

#### ARTICLE I. NAME

The name of this corporation shall be: Institute for Survivors of Incest and Sexual Violence, Inc.

Article II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS The initial mailing address of the corporation shall be: 725 North A1A, Suite C 108 Jupiter, Florida 33477

The directors of the corporation shall have the authority to change the principal place of business and mailing address in their discretion.

#### ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is to provide psychotherapeutic services and to develop and operate training programs for mental health professionals which will enable these professionals to address a variety of clinical issues. The corporation will also develop and operate training programs for other individuals interested in communicating effectively with people who are troubled or who have been traumatized. This corporation may also engage in any other activity in furtherance of its psychotherapeutic or educational purpose as authorized by the corporate bylaws.

This corporation is a non-profit educational corporation and is not organized for the private gain of any person. It is organized under chapter 617, <u>Florida Statutes</u>, Corporations not for profit.

## ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The method of election of the directors of this corporation shall be as stated in the Corporate Bylaws.

# ARTICLE V. LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.032 <u>Florida Statutes</u>, unless otherwise limited by the terms of these Articles of Incorporation or by the Bylaws of this corporation.

### ARTICLE VIII. CORPORATE TAX EXEMPT STATUS

- (A) This corporation is organized and operated exclusively for educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. This corporation shall apply for tax exempt status under section 501 (c) (3) of the Internal Revenue Code.
- (B) No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- (C) The property of this corporation shall be irrevocably dedicated to educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, or all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation or corporation that is organized and operated exclusively for charitable or educational purposes, and that has established its tax exempt status under section 501 (c) (3) of the Internal Revenue Code.
