A NON-PROFIT ORGANIZATION

We the undersigned subscribers to these Articles of Incorporation. Each a natural person competent to contract hereby associate ourselves together to form a corporation under the laws of the state of Florida.

### ARTICLE I – NAME

The name of this Corporation shall be known as  
**STRATEGIC WARFARE MINISTRIES, INC.** This corporation shall not join, belong, or pay dues to any other corporation. However, members may do so if they desire to.

### ARTICLE II – PRINCIPLE OFFICE

The principal place of business for the corporation shall be at 1441 NE 9 Street Homestead, Florida 33033.

### ARTICLE III – THE PURPOSE

The purpose of Strategic Warfare Ministries is:

A) To conduct activities which are exclusively charitable, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code, as the same may be amended from time to time.

- B) To build up men and women as leaders into the body of God, by equipping them with the wisdom, knowledge, and understanding of the Word of God. Therefore, they will become leaders in their homes, schools and community with the faithfulness of sharing the Gospel of Jesus Christ through the collective body of Christians by prayer and teaching.
- C) To have a syllabus that will cater to the needs of today such as Family, Marriage, Youth Crisis, Domestic Violence, HIV, etc. To renew their mind with knowledge and understanding to guide them in the right direction and to overcome the trauma, deception and despair that have began plaguing their lives.
- D) To engage in activities to aid the poor such as feeding the hungry, clothing the needy, aid to the distressed and the under privileged.

It is the ultimate goal of this organization to pursue the Christian quest for individual salvation while communicating the love, joy, and the good news of Jesus Christ our Lord and Savior.

#### **ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

Board of Directors is a group of person vested with the administrative excellence to govern the affairs of this corporation through the guidance of the Holy Spirit and Integrity of the Word of God. All candidates who desires to obtain a position of director must meet the following prerequisites:

- A) A supporter of Strategic Warfare Ministries of minimum one year.
- B) Must complete theological seminary course at Strategic Warfare Ministries and / or university or college.
- C) Must be a person who do not live a life of debauchery and / or licentiousness behavior, including but not limited to, Homosexuality, Transsexualism, molestation, and of the like. Involvement in such activities disqualifies the candidate from all consideration to occupy any position or office in this ministry. But they who live and conduct themselves honorably, morally, and ethically shall be considered.

D) Must contribute cheerfully and regularly as God have prospered you. Your giving will aid in promoting and advancing the Ministry.

After all prerequisites have been met, and carefully examination of the applicants; The Board of Directors will either approve or disapprove the applicant by a 2/3 vote by way of secret ballot.

The applicants will be notified within 14 days, as to the decision made.

If the approved candidate is believed and / or found guilty of treachery or bribery at any level, the CEO will reject the approved candidate and will appoint another candidate to occupy the position. Furthermore, an extensive investigation will be performed immediately by a special panel appointed by the CEO.
