**ARTICLE I** GENESIS II GROUP, INC. SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

FLORIDA Nonprofit Corporation Code.

**ARTICLE II**

(A). This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. (B) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

**ARTICLE VII**


