Please accept my sincerest apology for the delay in sending our Uniform Business Report. I checked the status at sunbiz.org only to find that T.W. Curtis Foundation Inc. was inactive\ua. I have been waiting to receive the UBR form, but it has not arrived.

I talked to a Reinstatement Examiner today and explained that we never received the UBR form, at either my address as registered agent, or at our corporate mailing address. I was told to write this letter of explanation for acceptance and request the late fee be waived. I was advised to download the UBR form and include a check for \$61.25.
