ARTICLE I: NAME

The name of the corporation shall be called Fresh Anointing International Ministries, Inc.

ARTICLE II: DURATION

The duration of this corporation shall be perpetual.

ARTICLE III: INITIAL REGISTERED
OFFICE & AGENT

The address of the initial registered office of this corporation is
2901 SW 41st Street, Ocala, Florida 34474
And the name of its initial registered agent is Angel Luis Cintron.

ARTICLE IV: PURPOSES

This corporation is formed to operate as a religious and non profit organization, including,
But not limited to the following purposes.

- 1.To preach the Gospel of our Lord Jesus Christ and care for the well being of mankind through out the world.
- 2.To provide Christian education, health care, ministerial and educational services to people in need locally and around the world.
- 3.To establish and maintain educational facilities, arts Christian facilities, health care facilities, clinic drugs and alcohol recovery facilities for men and women and other health providing facilities as approved By the board of directors.
- 4.To establish educational facilities for Christians Bible teaching and training of missionaries.
To ordain ministers and reverends to promulgate the teachings of the gospel of Jesus Christ.
- 5.To establish churches, teaching institutions, including research and missions for the promotion of the Christian Gospel locally and throughout the world.
- 6.To collect and distribute funds for the accomplishment of the purposes.
- 7.To operate exclusively for such other charitable and religious purposes as will qualify this corporation As an exempt organization under Section 501C3 of the Internal Revenue Code of 1954
(Or the corresponding provision of any future United States Internal Revenue Law,) including for such Purposes the making of distribution to organizations that qualify as tax-exempt organizations under said Code.

ARTICLE V: CORPORATE POWERS

The corporate powers of this corporation are as follows:

- 1.To make distribution to organizations that qualify as exempt organization under Section 501C3 Of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law.)
- 2.To adopt and use a common corporate seal and alter the same; provided, however, that Such seal shall always contain the word "Corporation Not for Profit."
- 3.To elect or appoint such officers and agents as its affairs shall require and allow them reasonable compensation.
- 4.Fresh Anointing International Ministries, Inc shall conduct its affairs within the meaning of the Statues and laws of the State of Florida and of the United States of America, as now existing or as hereafter amended or modified. Inconsistencies and interpretation of Bylaws shall be changed, Amended or repealed as necessary for the proper functioning of the corporation.
- 5.Membership of the corporation shall be composed of those people who become members and accept the rules and regulations, which is belief and faith in a Supreme Being. And in compliance to the principles of sound doctrine of the Christian principles as taught by the Lord and Savior Jesus Christ. The management of the corporation shall be vested of the Board of Directors of not less than three (3) No more than (15).
- 6.To contract and incur liabilities, burrow money at such rates of interest as the corporation may determine. Issue its notes, bonds and other chattel obligation and secure its obligations either by mortgage Or pledge of all or any of its property or income. To solicit and receive donations, endowments, to buy, own, and sell real estate and personal property, issue promissory notes in the corporate name, to mortgage Any property possessed by it and does any and all other things necessary to the proper management of the corporation.
- 7.To conduct its affairs, carry on its operations, have offices throughout the United States of America And other parts of the world, and exercising the powers granted pursuant to the laws of the State of Florida and the United States of America.
- 8.To purchase, take, receive, lease, take by gift, devise or bequest or otherwise acquire, own, hold, improve, are or deal in and with real or personal property, or any interest therein, wherever situated Either locally or in any other parts of the world.
- 9.To acquire, enjoy, utilize and dispose of patents, copyrights and trademarks, and any license or any other rights or instruments thereafter or hereunder appertaining.
- 10.To purchase, take, receive, subscribe, for or otherwise acquire, own, hold, vote, use employ, sell, mortgage, lend, pledge or otherwise dispose of and otherwise use and deal in and with shares and other interests in or obligations of other domestic or foreign corporations, whether for profit or not for profit, associations, partnerships or individuals, or direct or indirect obligations of the United States of America or of any other governmental district, municipality or any instrumentality thereof.
- 11.To lend money for its corporate purposes, invest and reinvest its funds and take and hold Real Estate and personal property as security for the payment of funds so loaned or invested.
- 12.To make donations for the public welfare or for religious, charitable or other similar purposes.

13.To have and exercise any and all other powers necessary or convenient to effect any or all other purposes for which the corporation is organized, including all of the rights, powers, privileges and immunities accorded by law to similar charitable non-profit organizations, with such additional rights, powers, privileges immunities as may be necessary, proper, or incident to the conduct of business Aforesaid and as may be inherent in or allowed to like non-profit charitable corporations under the laws Of the State of Florida as they now exist or may hereafter exist.

14.To have the right, power and authority to make rules and regulations, adopt bylaws, hold regular meetings and select such officers as they think necessary and as proper; to delegate any part of its authority or any portion thereof to committees, persons or subordinate bodies; to increase the number of members of the Board to any amount not to exceed or be less than the maximum and minimum prescribed by this charter; to fill vacancies in their number which from time to time exist by virtue of the expiration of term of office, death, resignation, or increase in the number of directors, or otherwise; To fix the terms of there own offices and of their successors and in general to have and exercise all powers of management and direction for the affairs of this corporation.

ARTICLE VI: MEMBERSHIP QUALIFICATIONS

No persons may become members of directors of this corporation other than the incorporating directors or their successors appointed or elected appointed as provided in the Bylaws or such other persons as may be elected or appointed as provided in the Bylaws. The Chairman of the Board, President, Vice President must be members of the Board of Directors, but other officers may be elected or appointed who are not members of the Board of Directors.

1.No part of the net earning of this corporation shall inure to the benefit of, or be distributable To its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attending to influence legislation and this corporation shall not participate in or intervene in (Including the publishing or distributing of statements,) any political campaign on behalf of any candidate For public office. Notwithstanding any other provision of these Articles of Incorporation, this corporation shall be carried on by:

a) A Corporation exempt from Federal Income Tax under Section 501C3 of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law,) or

b) By a corporation, contributions to which are deductible under Section 170C2 Of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law.)

2.The Board of Directors may cause this corporation solicit, collect, receive, and accumulate, Administer and disburse funds in such a manner as will, in the sole discretion of the Board Of Directors, most effectively operate to further the purpose of this corporation.

ARTICLE X: DISSOLUTION





