ARTICLES OF INCORPORATION

OF

BayWinds Wind Symphony of Tampa Bay, Inc.

(A Corporation NOT FOR PROFIT formed under the Florida General Corporation Act)

ARTICLE I- NAME

The name of this non-profit corporation shall be **BayWinds Wind Symphony of Tampa Bay, Inc.** This corporation shall be referred to as "BayWinds Corporation" in this constitution.

ARTICLE II- PLACE OF BUSINESS AND DURATION

The principal place of business for the BayWinds Corporation:

Term of existence of the BayWinds Corporation is perpetual unless dissolved according to law. The corporate existence shall commence at the time of filing with the Secretary of State.

ARTICLE III- PURPOSE

The Corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

Specific Purposes of this Corporation: *Create and maintain a wind ensemble of professional quality which performs, premiers, and encourages the composition of literature for the wind band.* The BayWinds Corporation defines these missions:

- Promote and perform significant wind band literature
- Utilize the most proficient professional musicians of the Tampa Bay region.
- Provide outreach and music education opportunities.
- Premier and commission works for wind band.
- Present programming that represents the full spectrum of band music, yet appeals to, and connects with a large audience.
- Develop national and international relationships through guest conductor appearances, recordings, and performance tours.
- Secure funding through grants, corporate sponsorship, patronage, and concert admission fees.


ARTICLE VI-ORGANIZATION




ARTICLE IX- DISTRIBUTION OF ASSETS IN DISSOLUTION
