Article III(c) reads:

(c) with the approval of not less than three fourths (¾) of each class of members, borrow money and mortgage or pledge of personal property of the OWNER'S ASSOCIATION as security for such borrowed monies.

Article III(c) shall be revised as follows:

(c) with the approval of not less than 66.67% members, borrow money and mortgage or pledge of personal property of the OWNER'S ASSOCIATION as security for such borrowed monies.

Article IV reads:

Article IV

The OWNER'S ASSOCIATION shall have two classes of voting members as follows:

Class A. Class A members shall be all owners owning Units with the exception of the Declarant, and shall be entitled to one (1) vote for each Unit owned. When more than one person holds an interest in a given Unit, all such persons shall be members and the vote for such Unit shall be exercised as they determine amongst themselves. In no event shall more than one (1) vote be cast with respect to any Unit owned by Class A members.

Class B. The Class B member shall be Declarant, who shall be entitled to exercise three (3) votes for each Unit owned. The Class B membership shall cease upon sale of the last Unit.

Article IV is deleted in its entirety and replaced as follows:

Article IV

The OWNER'S ASSOCIATION members shall vote as follows:

Members shall be all Unit Owners and shall be entitled to one (1) vote per Unit owned. When more than one person holds an interest in a given Unit, all such persons shall be members and the vote for such Unit shall be exercised as they determine amongst themselves. In no event shall more than one (1) vote be cast with respect to any Unit Owned by members.

Article X reads:

Article X

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto. Any amendment to these Articles may be made as provided under applicable law except that an amendment of the provisions of Article XI shall require the approval of the holders of three fourths (75%) percent of the total votes in Class A Membership and approval of the Declarant as the sole holder of the total votes in Class B Membership.

Article X is revised as follows:

Article X

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto. Any amendment to these Articles may be made as provided under applicable law except that an amendment of the provisions of Article XI shall require the approval of the holders of 66.67% percent of the total votes.
