## AMENDMENT TO ARTICLES OF INCORPORATION OF

### COMMITTEE FOR ART IN THE PARK-INC.

### **ARTICLE II**

The principal place of business address:

1120 White Street Key West, Florida 33040

The mailing address of the corporation is:

P.O. Box 7 Key West, Florida 33041

#### ARTICLE III

The specific purpose for which this corporation is organized is:

This corporation (Committee for Art in the Park Inc.) is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501(c) (3) of the Internal Revenue Code.

The Committee for Art in the Park Inc. is organized for the purpose of sponsoring and exhibiting sculpture and other fine art at Fort Zachary Taylor Historic State Park in Key West, Florida.

### **ARTICLE VIII**

Upon the dissolution of the corporation, the Board of Trustee shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation. In such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal officer of the corporation is then located, exclusively for such purposes or to such organization organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
