ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I – Name

The name of the corporation shall be the "BBCHS Tigerettes, Inc." It shall be a non-profit organization as duly filed.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

937 Greenbriar Drive, Boynton Beach, FL 33435

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is:

To promote the interest and activities of the Boynton Beach Community High School Tigerette Dance Team. To organize the activities of the parents of students in the Tigerette Dance Team of the Boynton Beach Community High School, when activities are for the purpose of providing either financial or other assistance to any program specifically involving the Dance Team. The activity or activities are to be agreed upon by a majority of the members in attendance at the regular meeting of the BBCHS Tigerettes, Inc., when the activity or activities are presented for approval.

ARTICLE IV – MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The elected officers are President, Vice-President, Secretary, and Treasurer, which are elected yearly. There are no limitations to the length of time an officer can hold.

The President shall appoint a Nominating Committee in February, consisting of three (3) voting members to nominate officers for the coming year. Nominations from the floor shall be accepted.

Nominees must be parents of Dance Team members or faculty members of the Boynton Beach Community High School.

The officers shall be elected at the April meeting by written ballot prepared by the Nominating Committee. The officers shall assume their duties at the May meeting.

In the event an officer cannot fulfill a term of office, the President, with the concurrence of the Executive Committee, shall appoint a replacement to complete the year.

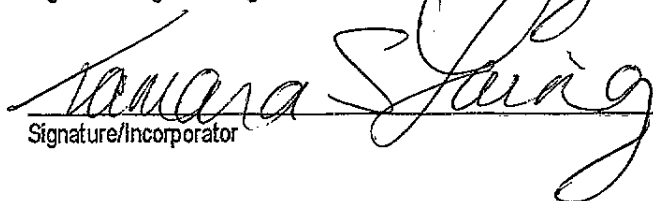
