ARTICLE 1. NAME

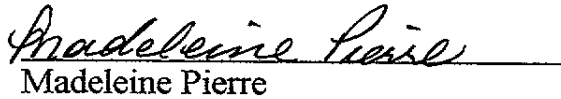

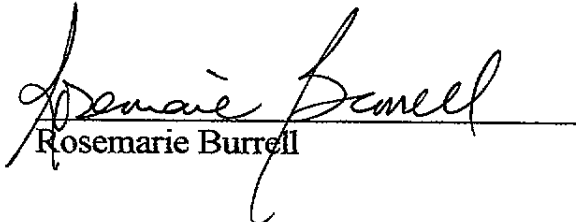
ARTICLE ~~X~~ AMENDMENT
