Articles of Incorporation  
of  
Christian Financial Services-Jacksonville, Inc.

The undersigned, acting as the incorporators of a corporation pursuant to Chapter 61 of the Florida Statutes, the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article 1

The name of the corporation is CHRISTIAN FINANCIAL SERVICES-JACKSONVILLE, INC.

Article 2

The principle place of business and the mailing address of this corporation is, 10482 Wellington Springs Way, Jacksonville, Florida 32221, Duval County.

Article 3

This corporation is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986, (or the corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the providing of financial counseling, seminars, workshops and educational courses, training and materials to churches, Christian schools, Christian Colleges, Mission Boards, and other Christian ministries to enable them to fulfill their ministry vision, to reach more people with the Gospel, to fulfill their God-given financial responsibilities and accountability with integrity and credibility, and to engage in any other activity not prohibited to corporations under the Florida Not For Profit Corporation Act that is in furtherance of federal tax exempt purposes.

Article 4

The method of election of directors shall be stated in the Bylaws of the corporation. The corporation shall have a minimum of three (3) directors. The directors and officers of this corporation shall be Christians who meet the biblical qualifications of Godly leaders as stated in 1 Timothy 3:1-7; Titus 1:6-9, and the Statement of Faith set forth in the Bylaws of the corporation. ## Article 5

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 3.

## Article 6

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, religious, or educational purposes as shall at the time qualify as an organization exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

## Article 7

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

## Article 8

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against directors, officers, employees, applicants, participants, and others on the basis of race, color, or national or ethnic origin.

## Article 9

The street address of the initial registered office of the corporation is 10482 Wellington Springs Way, Jacksonville, Florida 32221, and the name of the initial registered agent of the corporation at the initial registered office is Donald White.

## Article 10

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be

carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

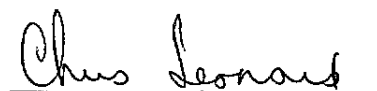

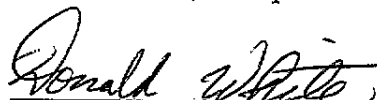
#### Article 12
