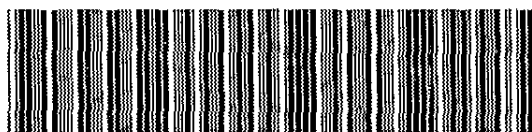

Pursuant to Section 617.1403, Florida Statutes, this Florida not for profit corporation submits the following Articles of Dissolution.

FIRST: The name of the corporation is FLORIDIANS FOR PRINCIPLE BASED GOVERNMENT, INC.

SECOND: The corporation has no members or members with voting rights.

The date of adoption of the resolution by the board of directors was June 18<sup>th</sup>, 2004.

The number of directors in office was three and the vote for the resolution was three for and none against.

THIRD: A copy of the corporation's Plan of Distribution of Assets, authenticated by the President of the corporation and containing the President's certificate of compliance with the requirements of subsection (2) of Section 617.1406, Florida Statutes, is attached.


**PLAN OF DISTRIBUTION OF ASSETS OF FLORIDIANS FOR PRINCIPLE  
BASED GOVERNMENT, INC.**

RESOLVED, that the following is the Plan of Distribution of Assets of Floridians for Principle Based Government, Inc.:

- (a) All liabilities and obligations of the corporation shall be paid and discharged, or adequate provisions be made therefor;
- (b) Assets held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements;
- (c) Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the dissolving corporation, as provided in the plan of distribution of assets;
- (d) Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or the bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others; and
- (e) Any remaining assets shall be used to purchase such incidental goods or services to further the purposes of the corporation as the amount available may permit, but without any continuing obligation to the provider of such goods or services.
